

Welcome to the 3rd newsletter of the **TUNE UP Interreg Med project!**

Despite the ongoing covid19 crisis, the 3rd project semester (January – June 2021) was full of activities for the TUNE UP partnership.

The “Testing phase”, aimed to develop local Memoranda of Understanding (MoUs) as a tool to improve governance and hence management policies in

10 Marine Protected Areas (MPAs)

in the Mediterranean Sea, is now concluded. The local MoUs are signed agreements between stakeholders that consist of a set of commonly agreed actions that deal with pressures, threats and conflicting interests related to the governance, environment and socio-economic development of the project pilot sites. To this end, the partnership engaged a variety of public and private stakeholders through a participatory process in the form of territorial labs. At each pilot site, the territorial labs were framed by local conferences, aimed to first introduce stakeholders to the project objectives and methodology and invite them to participate in the labs and then to encourage them to sign the local MoU.

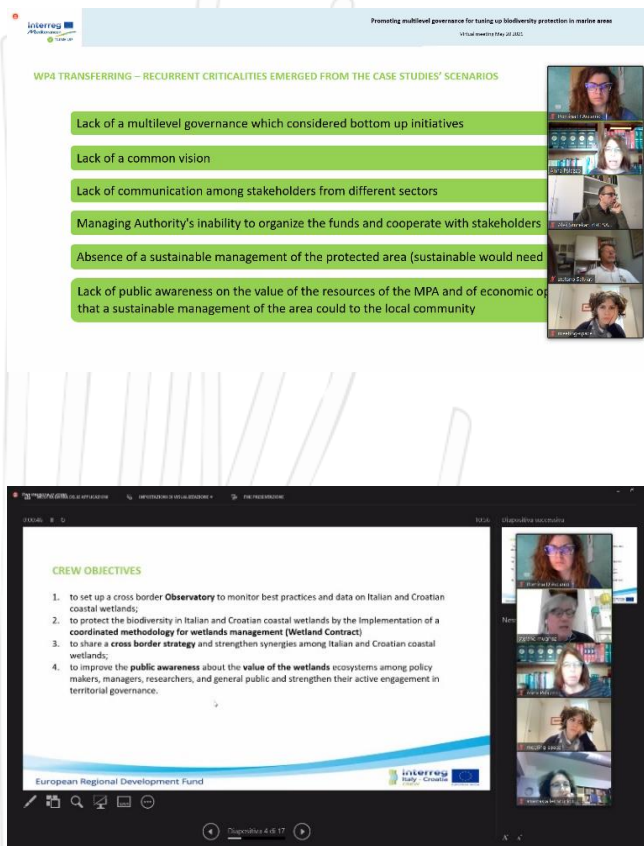

To promote the local MoUs as a tool that could be replicated in other areas, as well as to engage more stakeholders in the future, the partnership produced **short videos**, where local and regional stakeholders talked about their ongoing activities and presented their vision for a better future at each pilot site and at the Mediterranean region as a whole.



Following the Testing phase, the partnership has also initiated the second stage of the “**Transferring phase**” that aims at transferring the produced knowledge and know-how to different contexts and to potential stakeholders beyond TUNE UP pilot sites. To this end, the partnership has been evaluating local experiences derived from the drafting of the local MoUs to prepare a report on **joint methodology for MPAs integrated management** that will be later disseminated through special events to a wide audience. An internal meeting was held in late May to discuss on the criticalities emerged in each pilot site with the participation of representatives from the [CREW Interreg Italy-Croatia project](#) who presented their own experience.



During this semester the partnership attended several **informational events** in order to disseminate the project objectives, methodology and outputs within the Interreg Med community and beyond, but also to learn more about similar initiatives that are carried out in the Mediterranean region and establish synergies with ongoing projects.

The semester started and concluded with two important dates, the World Wetlands Day on the 2nd of February and the World Environment Day on the 5th of June. The partnership celebrated both dates by attending a [workshop](#) organized by the CREW Interreg Italy-Croatia project, as well as the virtual sessions of the [2020 MPA Forum](#) and a [workshop on pollution](#) in the Mediterranean, both of which were held during the [EU Green Week 2021](#).

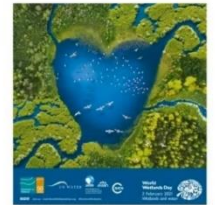

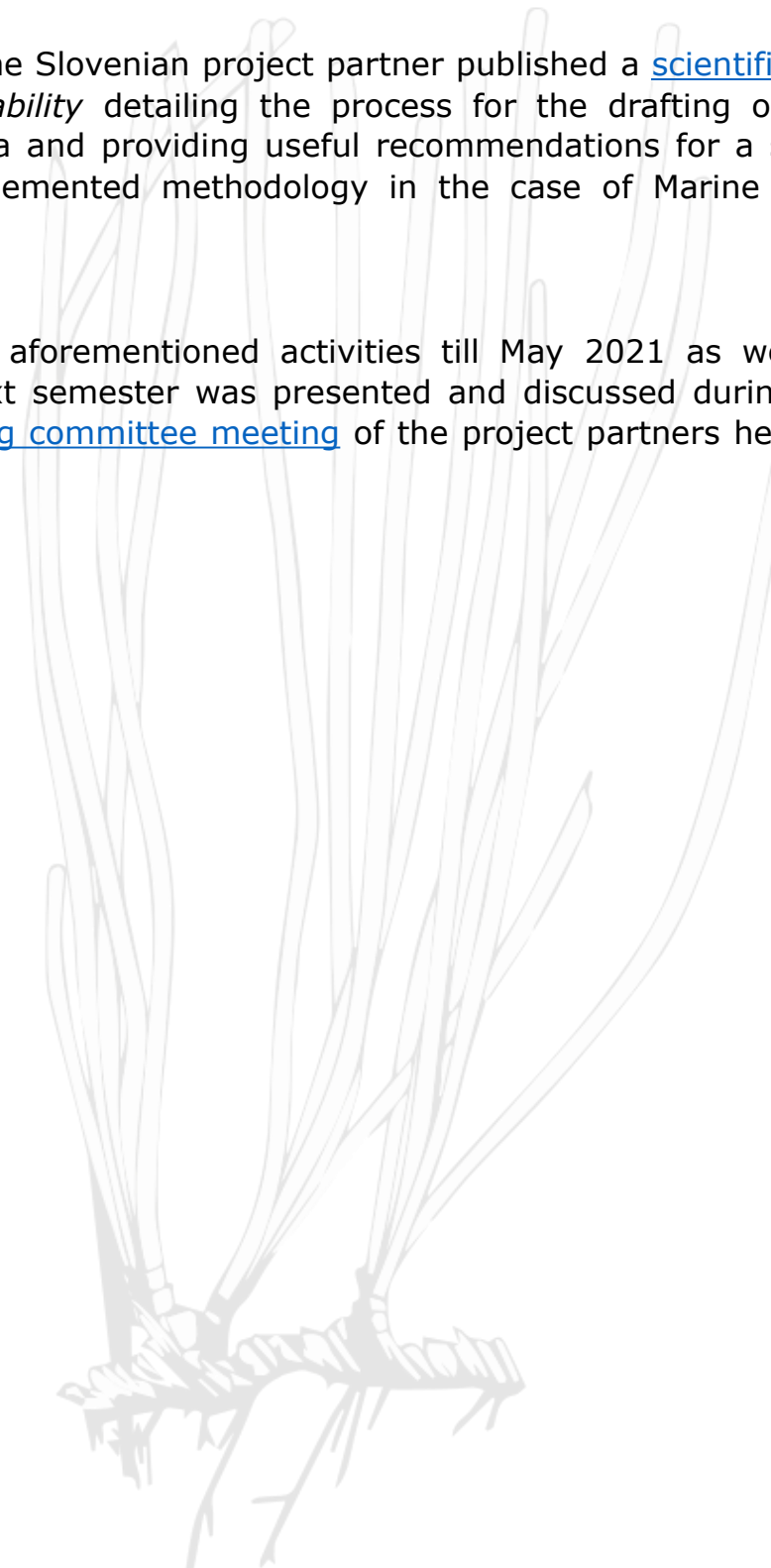
